or 60 Mile (\$25 by Aug 15th/\$35 after)

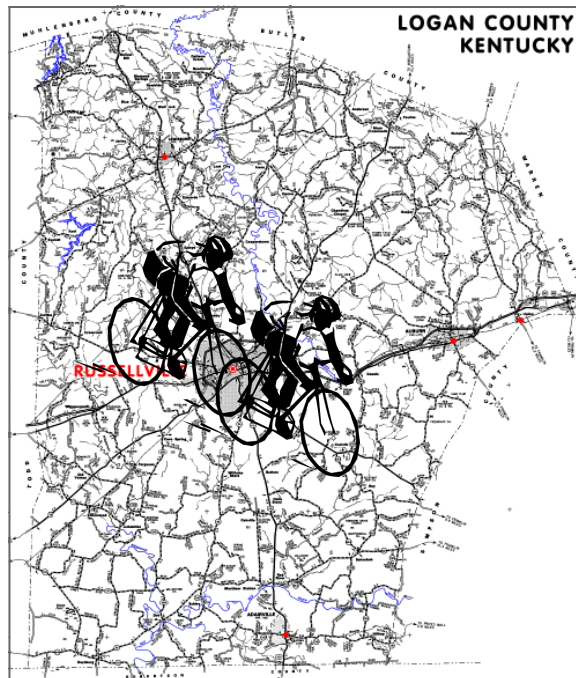
Rules

Helmets must be worn at all times while riding! All riders under the age of 16 must be accompanied by an adult.

The Course

Riders will cycle on one of three circular courses laid out through the rolling farmland of southern Logan County. The ride will start and end at Dripping Spring Baptist Church, front parking lot, in the Olmstead Community, with the finish circling back to the same location. At anytime during the ride, you may turn around and head back to the start location, to shorten the ride. The course will include road hickies, SAG stops, and SAG vehicles.

Traffic control will be provided by the Russellville Police Department and the Logan County Sheriff's Department.



The Logan's 228th Century Ride is a METRIC Century (100 kilometers or approximately 60 miles.)
