- EVENT: 2025 Logan County Tobacco & Heritage Festival on the Square in Russellville, KY.
- DATE: Saturday, October 11, 2025, from 9:00-4:00 pm and/or 4:00pm-10:00pm
- <u>VENDOR FEE</u>: No Electricity: \$400.00 for non-members and \$300.00 for Chamber members. Electricity Needed: \$500.00 non-members and \$375.00 for Chamber Members. Spaces are up to 30 feet long. Spaces over 30 feet will have an additional charge of \$125.00 per 10 feet needed. If we deem the space you request considerably larger than what we are allowing each vendor, you will be charged the additional fee. Please return the application and the booth fee to:

• OCCUPATIONAL LICENSE: Enclosed is a registration for Occupational License form from the City of Russellville. In order to have a vendor's stand, an occupational license registration must be on file with the City of Russellville. Please be sure to fill out all parts of the registration form so that there will be no delays in processing it. This License is effective for one year. If there are questions regarding the application and/or license, please call the Russellville City Hall at (270) 726-5002. • **HEALTH DEPT. PERMIT:** A temporary permit application is enclosed. You are responsible for purchasing this permit, filling it out, and returning it. The cost of a temporary permit is \$60. Please read all enclosures pertaining to food services and adhere to all rules. Please return your temporary permit, permit fee, and copy of your Festival application to:

• MENU REQUIREMENTS: For planning purposes, please submit a complete menu with prices that you will be presenting to your customers on Festival day. This will ensure a variety of food selection and fair pricing among vendors. Submitted menu and prices need to be clearly displayed for customers on the day of the event. Please keep in mind that once prices are submitted that this will be the required selling price on Festival day.

- <u>WATER</u>: There are **ABSOLUTELY NO WATER HOOK-UPS** available for vendors on Festival day. Please bring your own water for all washing, cooking, cleaning, etc. as required.
- **ELECTRICITY:** If electricity is needed, please note your **specific requests** on the acceptance reservation sheet. We have a limited number of outlets, and they will be assigned on a first come, first served basis. There will be no alteration of electrical services once confirmed.
- LOCATION ASSIGNMENTS: Location assignments will be determined according to the amount of space needed, the date your application is received, and the electrical availability. There are a limited number of spaces available. There will also be a select number of food specialties allowed. Vendors that participated the previous year will be allowed to set up in the same spot, if reserved by July 30th. You will be sent a confirmation in September.
- <u>SET-UP</u>: Vendors may begin set-up at 6 a.m. and must be ready for customers by 9 a.m. Vendors are asked to remain at the Festival from 9 a.m. until at least 4 p.m. You are welcome to remain on the square selling until the end of Festival (approx. 8 pm) if you wish.

The crowd for the festivities during the Tobacco & Heritage Festival is estimated to be 35,000. We hope that you will choose to be a part of the Festival.
